### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The Central Illinois Continuum of Care is made up of 11 counties. The area is largely rural with three major cities within the CoC where the majority of services are offered. PATH is the planning entity for the Continuum and will be the lead for the Coordinated Entry to ensure that the system is working as designed and evaluation of the system is being done in a timely manner. The large geographical area makes it difficult for the CoC to ensure that all counties are covered. The Coordinated Entry Committee determined that a 2-1-1 phone center was the best option for coverage. The Continuum will use the current 2-1-1 system that is operational in all 11 counties and managed by PATH. All individuals who are experiencing a housing crisis will be directed through various marketing campaigns to call 2-1-1 for assistance. Once an individual or family connects to 2-1-1 they will be connected with either a trained volunteer or a trained Coordinated Point of Entry staff who will attempt to prevent and divert them from the system by utilizing resources to help with rent and utility assistance. If an individual is not able to be diverted they will be assisted in located emergency shelter. If an individual is able to obtain shelter the shelter staff will be responsible for conducting a VI-SPDAT or VI-FSPDAT with the individual in the next 5 business days to ensure the individual was added to the CICoC Prioritization List for housing. If no shelter can be located for the individual or family they will be referred to their nearest HUB and outreach worker for assistance in obtaining a VI-SPDAT assessment. This process does take into consideration those families fleeing a domestic violence situation. These families will still participate in the system, but with an ID number only to ensure the high level confidentiality required by the law. The budget includes funds for two part time staff to assist in the hubs and the 2-1-1 call center. This will allow for housing counseling assistance as well as VI-SPDAT completion. These staff members will also be in charge of staying in communication with the projects throughout the continuum to identify openings. Once an opening for a referral has been made the CPOE staff will be in charge of determining the next referral from the prioritization list and assisting them in being placed. There are funds for the traveling expenses in the budget as well. Because the Continuum is a large geographic area, moving costs will be incurred in order for clients to get to their housing of choice. Lastly the budget includes a small amount for ensuring the process is publicized to include flyers and pamphlets.

These flyers will also be posted in churches, libraries and places of businesses as approved. The flyers will have the 2-1-1 number as well as the location of the hubs, what the coordinated entry will be able to assist with. These flyers will be in English as well as Spanish as these are the two primary languages in the area. The system will also be advertised on the PATH, inc. website as this agency is the Lead Entity for the CoC. Other agencies will be able to post on their websites as well. The Coordinated Entry Committee will also look at the feasibility of using Facebook as a source of advertisement

**4d. Does the coordinated entry process use a comprehensive, standardized assessment process?** Yes

Individuals and families that are experiencing a housing crisis will be directed to call 2-1-1, a referral and information system. Trained 2-1-1 staff will be able to assist individuals identify what assistance they need, and will be able to divert them from the system when possible. If the individual is unable to be diverted they will be connected to trained Outreach staff who will then be able to assist them in completing a VI-SPDAT or a VI-FSPDAT. Once the assessment is completed the client will be referred to any available and appropriate housing options. If there are no openings the client will be added to the prioritization list. The trained Coordinated Point of Entry staff will regularly contact those on the list to ensure information is up-to-date, and to assist with housing needs until an appropriate opening is available. If there are no housing opportunities available, the client will be placed on the prioritization list in order of vulnerability. Once a housing opportunity becomes available the list manager will contact the most vulnerable person with that housing intervention. The client and the housing provider will then make a connection to further complete agency intake paperwork and secure the client housing.

Gentlemen:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

We have further determined you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in section 170(b)(1)(A)(vi).

You are not liable for social security (FICA) taxes unless you file a waiver of exemption certificate as provided in the Federal Insurance Contributions Act. You are not liable for the taxes imposed under the Federal Unemployment Tax Act (FUTA).

Since you are not a private foundation, you are not subject to the excise taxes under Chapter 42 of the Code. However, you are not automatically exempt from other Federal excise taxes.

Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal estate and gift tax purposes under sections 2055, 2106, and 2522 of the Code.
