The Planner leads bimonthly, full Continuum meetings. These provide a forum on current homeless issues and progress on goals for individual projects. The Continuum is largely rural with three hubs monitored and assisted by the Planner. Local meetings discern local issues, and each hub recruits new members such real estate organizations, churches, schools, police, and hospitals.

The Planner provides leadership for the Executive Board who drive decisions including annual rankings, strategic plans, and changing standards to meet HUDs guidelines.

The Planner ensures subcommittees are operating effectively — the Planner contacts each chair to provide support.

The Planner and Committee update the governance charter for its annual assessment. All parts of the charter are evaluated to make sure the CCoC it is compliant with HUD regulations.

The Planner monitors CoC funded activities. CoC monitoring is done within 40 days of the agency’s end of operating year. The Planner gives feedback for improving statistics for their APR.

The Planner monitors the Coordinated Entry (CE) process. The CE process utilizes existing hubs as well as the utilizing assessment and intake through 2-1-1 services, operating 24/7. Evaluation of the CE system review tool, developed by the Planner, will ensure the CE system is working successfully within HUD guidelines to enhance access. The tool will be implemented quarterly to get a baseline. Once completed, the tool will evaluate the system semi-annually.

The Planners mission is to establish and maintain program standards. Along with the full continuum, the Planner works on strategic plans. The annual gaps analysis is a part of the strategic process. This multi-step analysis starts looking at HMIS, monitoring and unmet needs data. A preliminary report goes to the full continuum for review — the Planner documents potential solutions and monitors progress.

The Planner person prepares the CoC Applicant grant and reviews the project applicant grants before submission. New projects are sought. The Planner and Ranking Committee are responsible for ranking the projects.

The Planner coordinates the PIT, HIC, and LSA. The PIT planning process starts in November to coordinate with agencies and volunteers and to develop a plan for counting the street homeless. The HIC forms will be sent out in early January with detailed instructions on how to complete it. When requests for work on the LSA come out, the Planner will do weekly updates to HMIS data to comply with standards.

The Planner coordinates the Emergency Solutions Grant program. ESG monitoring occurs early in the calendar year.

Below is the estimated schedule for proposed planning activities:  
HMIS Data Quality and Cleaning: it is on-going and as needed. Special attention is given at the end of the operating year before the submission of APR or CAPER. These efforts will assist with the submission of the LSA when requests for cleaning come out for that.  
Track Submission of APRs and CAPERs: Ongoing with each project particularly when an operating year has ended.  
Monitoring CoC: Within 40 days of the end of the operating year for that specific project.  
CoC Strategic Plan: Working with the Continuum Executive Committee. The strategic plan also means to update the Governance Charter and all procedures and policies. 10-1-2020 to 7-1-2021  
Researching and Implementing new Monitoring Tool: 10-1-2020 to 4-1-2021  
Coordinate PIT and HIC: 11-1-2020 to 2-1-2021  
Annual Gaps Analysis of Homeless Needs and Services: 12-1-2020 to 3-1-2021  
Monitoring ESG: 1-1-2021 to 3-31-2021  
Researching and Implementing new Ranking Tool: 1-1-2021 to 5-1-2021  
CoC Competition: Registration and Review at time HUD opens them up. 5-1-2021 to 8-31-2021 for the rest of the competition (contingent on when the NOFA is released).  
Our Continuum’s strategic plan will feed into the management plan. The plan will include a detailed list of the scope of planning activities with their proposed completion dates. Each activity will also discuss the possible barriers or risks to successful completion of the activity.  
The planning position will be supervised by the executive director of the Lead Agency, to assure effective and timely completion of all work. This person, Karen Zangerle, initiated the CoC for our community back in 1999 and has 20 years of experience and knowledge to bring to the process. The Executive Board of the Continuum will also be involved in the timeline of proposed activities and have a copy of the management plan. Currently the Board has members involved since the beginning of the CCoC. Additionally, the planning position will report to the Executive Board every month on the progress towards completion of these activities. These provide two sources of oversight with the planning position that will help assist in the operation of the Continuum.

**3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?**

The planning position will drive better statistics that show the economic value of the programs as well as the quality of funded projects. Continue to improve the CoC's ability to evaluate the outcome of CoC and ESG projects as there currently is not a single entity that has this as a responsibility. A uniform monitoring tool will be created to ensure objectivity when evaluating projects. On-site evaluations are more easily conducted with these funds. This position will allow for time to monitor HMIS input from all organizations and allowing for more control over input through coordinated assessment.
